


The CEDI Coalition is composed of a diverse set of eleven colleges and universities. The eleven schools that make up the N-CAE CEDI community are as follows:

#### MAPPING TSC'S TWO NEW CERTS

# VALUETHE STUDENT EXPERIENCE IN THE KU MAPPING PROCESS

Colorado CEDI: Three Different Levels of Analysis (Micro, Mezzo, and Macro) to Align KUs to TSC-Alamosa Valley CLOs

Students experience curriculum from the micro perspective of the individual subject undergoing transformation.

Instructors experience curriculum from the mezzo perspective and work with groups of subjects undergoing transformation.

Mentors experience curriculum with a macro (or statewide) perspective and work with multiple programs or institutions (of subjects) undergoing transformation.

- I) THE INSTRUCTOR/MENTOR DYAD OFTEN IGNORES THE UNDERGRADUATE STUDENT'S (FROM THE INSIDE) PERSPECTIVE.
- 2) INTRODUCING THE UNDERGRADUATE STUDENT'S PERSPECTIVE INTO THE MAPPING PROCESS CAN IMPROVE THE VALIDITY AND RELIABILITY OF THE ANALYSIS.
- 3) TEACHING THE UNDERGRADUATE STUDENT TO ENGAGE IN KU MAPPING WITH THE INSTRUCTOR AND THE MENTOR CAN PROVIDE THE STUDENT WITH A MORE HOLISTIC VIEW OF THE SUBJECT MATTER.
